

## Announcement

We would like to inform you about the following issues:

## 1. UPGRADE OF THE INSTANT CREDIT TRANSFERS SERVICE

The Bank has upgraded its Instant Credit Transfer Service (hereinafter the "Service"), which, as of 5<sup>th</sup> June 2025 will be available for both incoming and outgoing payment orders, aiming for their faster processing. The Service was initially launched on 7<sup>th</sup> January 2025 and, in the first phase, has been supporting only incoming payment orders.

Euro currency credit transfers processed through the Service, make funds immediately available in the beneficiary's account, as stipulated in Regulation (EU) 2024/886 of the European Parliament, the SEPA Instant Credit Transfer Scheme, and the SEPA Instant Credit Transfer Scheme Rulebook.

The Service is available 24 hours a day, on any calendar day, within the Single Euro Payments Area (SEPA). ## 2. REVISION OF THE BANK'S GENERAL TERMS AND CONDITIONS

The Bank has revised its General Terms and Conditions (hereafter "Terms").

The revised Terms will be in force as of 5<sup>th</sup> June 2025. In case you do not agree with the revised Terms, you have the right to terminate your relationship with the Bank with no charge, provided that the Bank shall receive a signed declaration of termination from you before 5<sup>th</sup> June 2025. If you do not notify the Bank of your non-acceptance before the above date, we will assume that you have accepted the revised Terms.
