- As outlined in the "Charges" category of the Key investor information document (KIID), Bank receives an inducement in the form of a percentage from the total management fee charged by Alpha Asset Management M.F.M.C. This percentage can vary from 0% to 50% and it's received for the provision for the investment services provided through Alpha Bank Gold Personal Banking. The amount of inducement received will be determined on the following two factors:
 - The retention period of the mutual fund
 - The category of the mutual fund.

The analysis of the amount corresponding to management fee is included in the «Annual costs report», which is sent to the customer on an annual basis and includes all costs and charges. An analysis of the aforementioned amount at any other time is available upon request.

The Bank will not charge a higher subscription fee to its clients than the respective commission as outlined in the mutual fund and SICAV prospectuses by International Management Firm. As outlined in the information document of the mutual funds and SICAV, the Bank will receive a subscription fee. The applicable amount from the Charges table above will be that of the higher amount.
- In relation to the applicable discount percentage, outlined in table 4 above, please note that it is identified based on the total value of the transaction or the total value of the portfolio under management, whichever is the highest.
- As outlined in the "Charges" category of the Key investor information document (KIID), Bank receives an inducement in the form of a percentage from the total management fee charged from each Fund House. The said percentage may vary from 0% to 65% and it's received for the provision for the investment services provided through Alpha Bank Gold Personal Banking, based on the following factors:
 - i. The retention period of the mutual fund
 - ii. The Fund House
 - iii. The category of the mutual fund

The analysis of the amount corresponding to management fee is included in the « Annual costs report», which is sent to the customer on an annual basis and includes all costs and charges. An analysis of the aforementioned amount at any other time is available upon request.

3. Commissions and Charges for Investment Services Products

- The minimum cost of maintaining an investment account amounts to Euro 9,00 quarterly (Euro 36,00 per year).
- Safekeeping fee amounts to Euro €1,25 quarterly (Euro 5,00 per year).

Both amounts (maintenance costs and safekeeping fee) are debited at the end of each calendar quarter.
