## Terms and Conditions of the Mastercard Cards Promotional Action

## "Alpha Spend and Win"

- The "Alpha Spend and Win" Programme (the "Programme") by Alpha Bank Cyprus Ltd (the "Bank") shall apply from 1 July 2025 up to and including 31 December 2025 and is addressed to all Holders of Alpha Bank Mastercard cards in EURO (Enter, Gold Enter, Gold, Business Debit, Cashback, Platinum, World Elite and World Business) (the "Card" and, in plural from, the "Cards").
